## 2. HAZARD IDENTIFICATION

## 4. FIRST AID MEASURES

**Eyes:** Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower lids.

## 5. FIRE FIGHTING MEASURES

This material is fire and explosion resistant. Heating beyond the melting range may generate fumes which are not flammable.

## 7. HANDLING AND STORAGE

Avoid inhalation of fumes while melting and dust while grinding. Wash hands thoroughly before eating or smoking to avoid ingestion.

## 8. EXPOSURE CONTROLS / PERSONAL PROTECTION

<b>Respiratory:</b>	Provide general ventilation and local exhaust to keep levels below the TLV stated in Section 3. Wear a NIOSH approved respirator for dust exceeding the TLVs.
<b>Hand:</b>	Latex gloves are recommended while grinding. Heat resistant gloves should be worn while casting and handling hot metals or moulds.
<b>Eyes:</b>	Wear eye protection suitable to each individual operation.
<b>Other:</b>	Wear apron, lab coat or other protective clothing.

## 10. STABILITY AND REACTIVITY

At ordinary and high (below the melting range) temperatures, the material oxidises but is stable. At very high temperatures the alloy produces fumes.

## 11. TOXICOLOGY INFORMATION

<b>Silver:</b>	Absorption of silver compounds by ingestion, inhalation or through broken skin can cause argyria, a permanent bluish-grey discolouration of the skin, conjunctiva and mucous membranes. Generalised argyria develops after 2-25 years of exposure. There are no systematic effects or symptoms and no physical disability. Silver is considered an experimental equivocal tumorigenic agent by RTECS criteria.
<b>Indium:</b>	May cause foetal effects based upon animal studies. May cause lung damage and blood abnormalities. Target organs: Blood, kidneys, liver and lungs.

This is an environmentally friendly material. With proper dust collecting equipment 100% of this alloy can be recycled.
